- Lyon is a 3-4 hour bus/train ride from Charles de Gaulle airport (in Paris). <https://www.sncf.com/>
- If you depart from central Paris you would commence the trip at Gare de Lyon.
- You can fly directly into Lyon (Lyon–Saint Exupéry Airport LYS) on various major airlines using their local partners, or other airlines (e.g. Ryan Air).
- OR:
- You can fly into Paris and take the train to Lyon (from Gare de Lyon in Paris to Part Dieu or Perrache in Lyon). Train travel in France is excellent.
- There is an airport shuttle to/from Gare Part Dieu train station to the Lyon Airport.

No visa is required to travel to France at this time if the stay is less than 90 days.

You will need a Passport with a minimum of 90 days before expiration.
